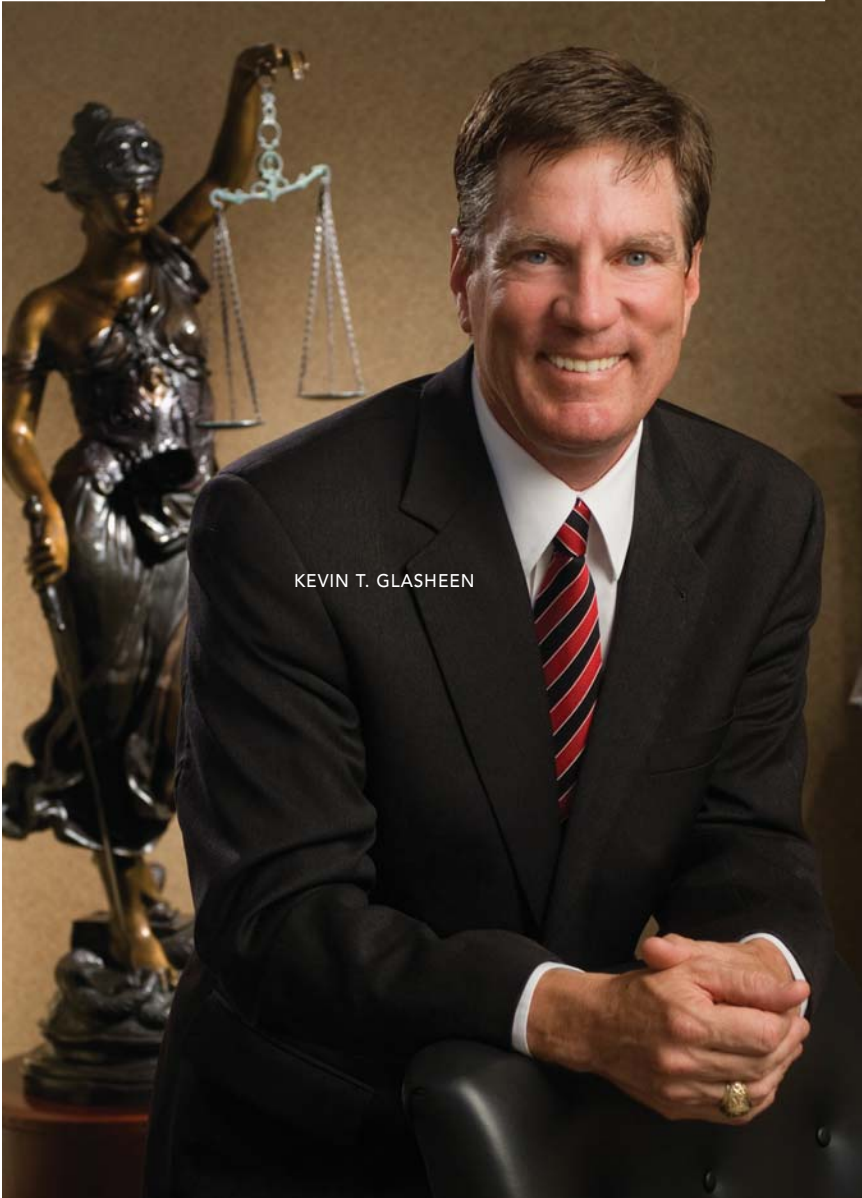

county. From that early success, Glasheen and the firm have successfully handled numerous major accident cases.
